 - FAMILY WORK


- 
- ADOLESCENTS & YOUNG ADULTS (12)
 - MOTHERS & CHILDREN (9 + 1)
 - SEVERAL ATTEMPTS AT TREATMENT
 - DUAL DIAGNOSIS
 - ADJUSTMENT OF PARENTAL RIGHTS
 - CLIENTS WITHOUT FAMILY BACKGROUND
 - JUVENILES WITH COURT ORDERED STAY IN FACILITY
 - DIFFICULT DEBT OR FINANCIAL SITUATION



- THERAPEUTIC COMMUNITY AS A METHOD
 - GROUP THERAPY / COUNSELLING
 - REGIME, ORDER AND RULES
 - SHARED RESPONSIBILITY
 - CODECISION
 - WORK SKILLS TRAINING
 - PARENTAL COMPETENCIES AND CHILD CARE


- PHAZE ZERO (14 – 21 DAYS)
 - ADAPTATION (CLIENT GETS TO KNOW THE COMMUNITY, MOTHER STARTS EITHER WITH OR WITHOUT HER CHILD)
- FIRST PHASE (2 – 4 MONTHS)
 - SEEKING TRUST, OPEN MIND, TESTING BOUNDARIES, TAKING RESPONSIBILITIES
- SECOND PHASE (2 – 4 MONTHS)
 - INTEGRATION, SELF-RESPONSIBILITY, HELPING OTHERS, TAKING CARE OF THE COMMUNITY, LEAVINGS AND VISITS, FAMILY WORK AND COUNSELLING
- THIRD PHASE (2 MONTHS)
 - SELF RELIABILITY, PREPARATION FOR LIFE ON THEIR OWN

- FROM 8 TO 14 MONTHS PROGRAM
 - SPECIFIC CHILD NEEDS ACCORDING TO A CERTAIN AGE
 - SUPPORT DURING NEGOTIATION WITH OTHER INSTITUTIONS, FAMILIES, PARTERS
 - TAKING RESPONSIBILITY FOR THEIR CHILDREN
 - SPECIFIC WORK WITH FATHERS AND OTHER RELATIVES

- 
- LENA
 - 25YO, 4YO SON, DISCOVERED PREGNANCY + MONTH AFTER ENTERING
 - AUTHORITY SUPERVISION, SON PLACED INTO FOSTER CARE OF NON-RELATIVE CAREGIVERS, NOT ALLOWED TO LEAVE KARLOV AREA WITHOUT PERMISSION
 - INTENSE THERAPEUTIC WORK
 - INTENSE WORK WITH STATE ORGANS, COURT, ASSUMED FATHER OF YET UNBORN CHILD (DRUG USER OR NOT?)
 - MOTHER OF THE CLIENT NEEDS HELP OF SOCIAL SERVICES HERSELF
 - LONG-TERM INDIVIDUAL TREATMENT SCHEME

- ELIS, 35YO, 5 MONTHS PREGNANT
 - OLDER DAUGHTER IN FAMILY FOSTER CARE (12YO)
 - GOOD FAMILY BACKGROUND AND SUPPORT
 - MARRIAGE FOR MONEY, DIFFICULT DIVORCE
 - COMMENCEMENT OF SENTENCE 365 DAYS AFTER GIVING BIRTH TO SECOND DAUGHTER
 - ALTERNATIVE SENTENCE IN COMMUNITY
 - EXECUTION OF ALTERNATIVE PUNISHMENT DURING TREATMENT UNDER PROBATION AND MEDIATION SERVICE.
 - SUCCESFULL, CURRENTLY IN THE AFTERCARE CENTER AFTER COMPLETING THE SENTENCE

 - CHILDHOOD TRAUMA, ABUSED BY HER FATHER
 - GOT SELLED INTO GERMANY IN YOUNG AGE
 - NON-USING HUSBAND, HUGE SUPPORT
 - LONG TERM TRAUMA HEALING
 - OLDER SON HAS DIFFICULTIES SPEAKING
 - COMPLICATED COOPERATION WITH HER FAMILY, ESPECIALLY MOTHER

 - DAUGHTER GOT PLACED INTO GRANMOTHERS FOSTER CARE
 - ROLE CONFLICT –FOSTER CARER / MOTHER/ GRANDMOTHER
 - DIFFICULT RELATIONSHIP, BIG TOPIC EVEN FOR AFTERCARE
 - PARTNER AND FATHER OF THE GIRL IS ABUSING, TRYING TO HIDE IT
 - CONSTANT AND FRAGILE TRUST SEEKING BETWEEN MOTHER AND HER
